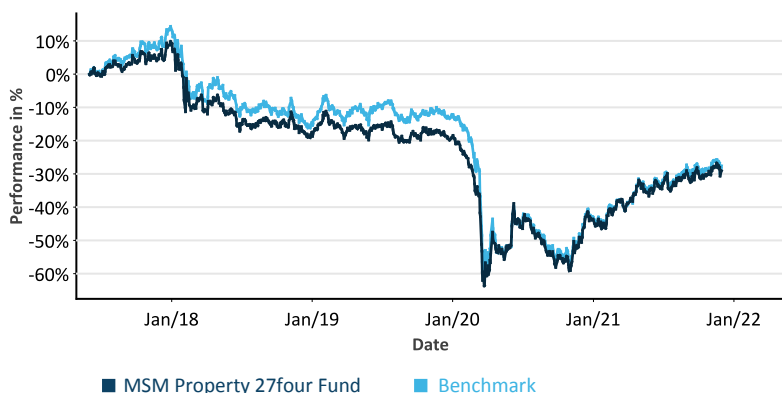

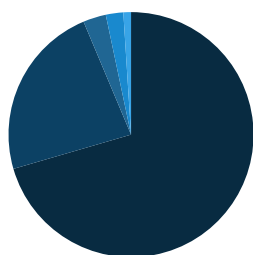

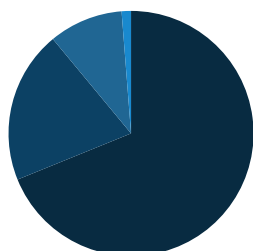

Sector Allocation

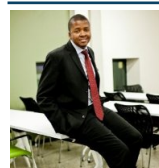

Monthly Commentary

The US economy powered ahead with jobs data exceeding expectations and unemployment rate falling to 4.6%. The Fed announced tapering of \$15bn for November and December but didn't increase interest rates, as it waits for full employment. President Biden passed the \$1trillion infrastructure bill. The ANC had to contend with coalitions for the local elections as they missed the 50% majority. The inflation rate exceeded 5% causing the Reserve Bank to increase interest rates by 0.25%. Global markets corrected with the announcement of Omicron By South Africa but recovered swiftly as temporary bans on southern Africa by the West, spread, even with cases in Europe being identified prior.

Glossary summary

Volatility: Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.

Risk Guidance
