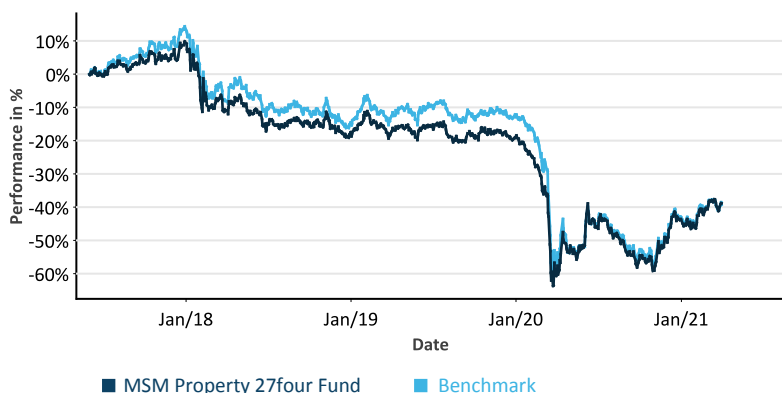


Cumulative Returns Since Inception

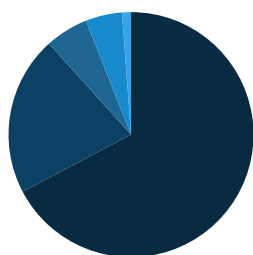

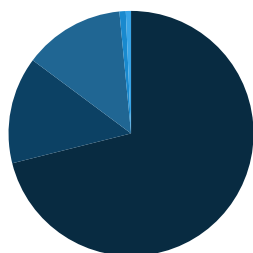

Monthly Commentary

March saw global equity managers worrying about rising bond yields as US job numbers along with vaccine rollout outpaced expectations spurring a commodity run. Joe Biden passed the \$1.9trn package and announced tax hikes for corporates and the wealthy thereby funding the proposed infrastructure bill. South Africa's GDP beat expectations at -7% for 2020 as SARB held rates whilst inflation dropped to 2.9% for February. The JSE (+12%) beat the SPX (+7%) and the Eurostoxx (+10%) for the quarter as miners led the charge. At 3% performance for the fund, we beat ALPI benchmark at 1.55%.

Glossary summary

Volatility: Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.

Risk Guidance
