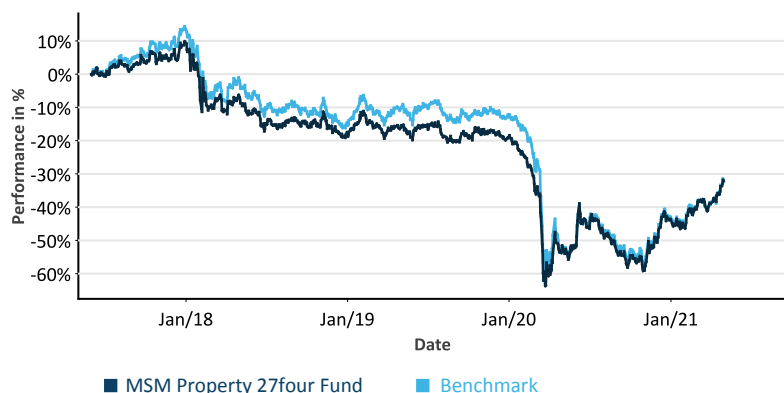

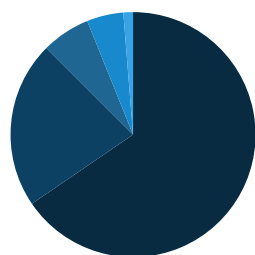

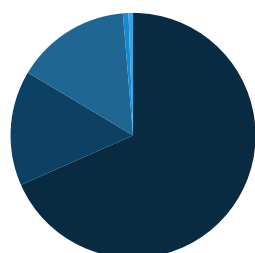

Monthly Commentary

Listed property was the best asset class on the JSE as it returned 11.4% for the month of April. As global markets worried about inflation, we saw commodities run and China reported its highest GDP growth at 18.3% for the quarter since 1990. India saw a surge in pandemic cases as it went into lockdown. The Rand strengthened to R14.51 and CPI data beat expectations at 3.2% y/y, showing the recovering South African economy. We underperformed the index due to our position in Growthpoint which performed well during the month but were saved by Vukile.

Glossary summary

Volatility: Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.

Risk Guidance
