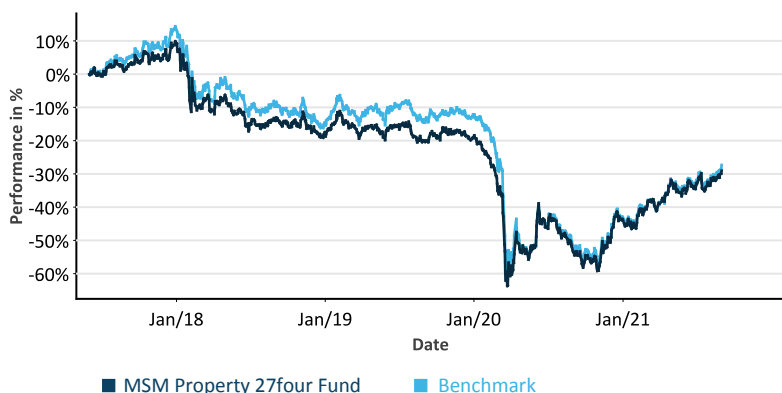

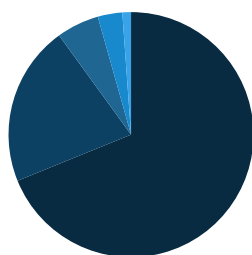

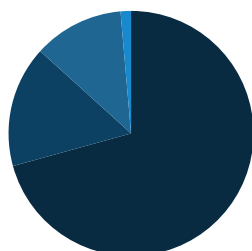

Sector Allocation

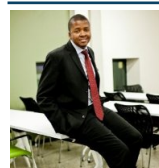

Monthly Commentary

August witnessed a recovery as the MSCI World ended up 2.5% following the Fed giving more clarity on the prospects of tapering and interest rate hikes. Even though Covid cases across the West increased due to the Delta variant, jobs data out of the US improved with unemployment ending at 5.4%. China continued its regulatory crackdown of the technology sector as industrial output and retail sales disappointed. South Africa saw the easing of Lockdown restrictions as manufacturing bounced back and earnings season surpassed expectations. Our fund ended up 6.8% as the JSE All Share index ended down -1.7%.

Glossary summary

Volatility: Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.

Risk Guidance
