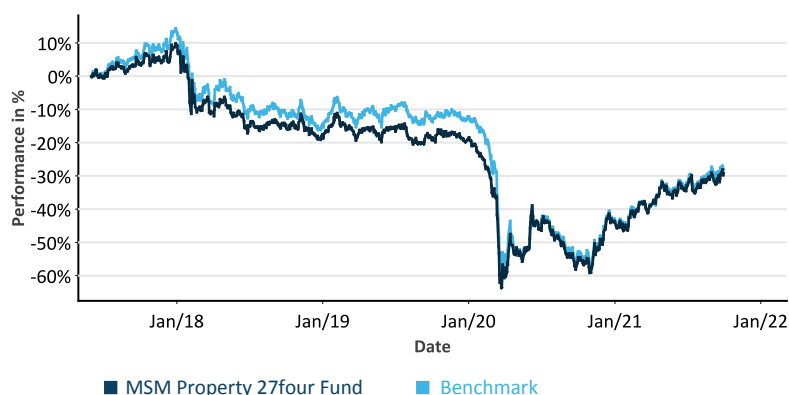


Cumulative Returns Since Inception

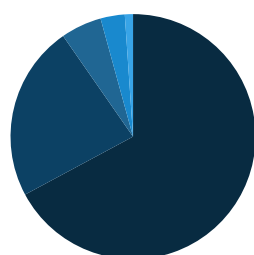

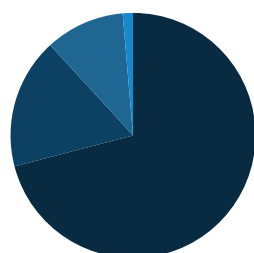

Sector Allocation

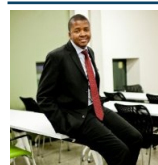

Monthly Commentary

Markets eased off during September as the Fed's hawkish tone spoke to possible tapering in November whilst Yellen called for the raising or suspending of the US debt ceiling. Oil broke the \$80 level whilst we saw a risk off sentiment for disappointing US jobs data. Supply chain issues plagued Europe whilst China continued with its crackdown on the technology sector. Lockdown levels were decreased in South Africa as infection rates decreased whilst GDP numbers beat estimates at 1.2% for the second quarter. Listed property was down -0.20% and the FTSE/JSE was down -1.1% for the month as the earnings season for listed property began.

Glossary summary

Volatility: Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.
