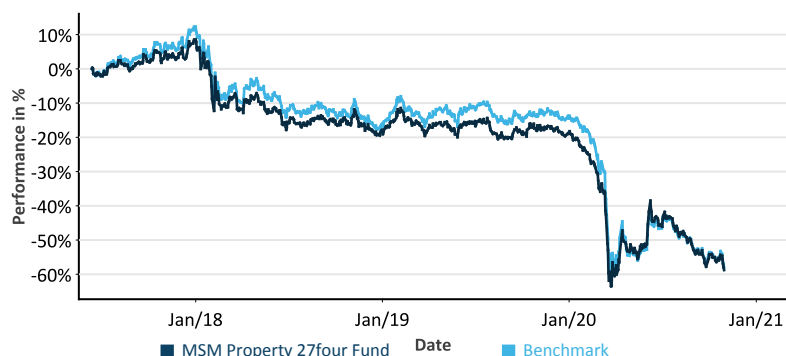
Investment Objective:

Monthly Commentary

The month of October saw global markets sink lower caused by Covid-19 cases resurging in the western hemisphere (second wave), the uncertainty of the US elections in November and the disappointment in the deadlock of negotiations regarding the proposed US stimulus. China pushed ahead with its de-dollarisation stance and held its fifth plenum. The president of South Africa delivered an economic plan, and the mid-term budget speech came in as expected. Listed property was down by -7.58% as SA markets saw foreign selling.

During the phase in period TERs do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER. The TER can be based on the management fee (including VAT) of 0.40% and projected audit fees, trustee fees, custody fees and other administration costs for the next 12 months. TCs can be based on costs incurred to date, annualised for the year, including STT and brokerage fees, VAT inclusive.

Risk Guidance
