Typically have medium to long term investment horizon i.e. 1 year and more.

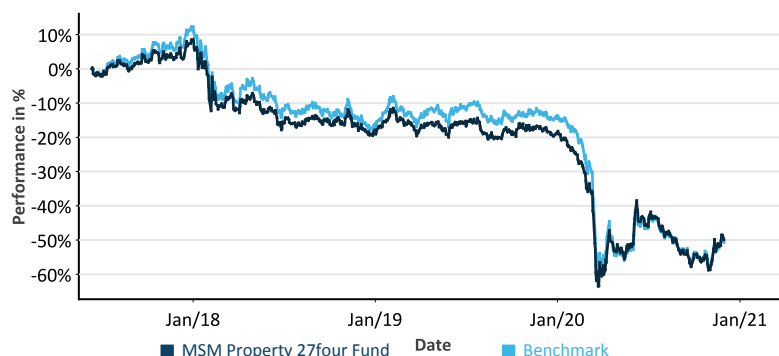
#### Investment Objective:

November saw performance of 21.5%, wiping out the last three months negative performance and more, as we capitalised on the Joe Biden win of the US elections and the release of the Pfizer vaccine news. Our risk on stance earned us the best performing manager in the listed property sector where the All Property Index was up by 18.3%. The Reserve Bank left rates unchanged whilst the Purchasing Managers Index ticked up, reinforcing the recovery view of the economy, even though Black Friday disappointed.

### Risk Guidance
