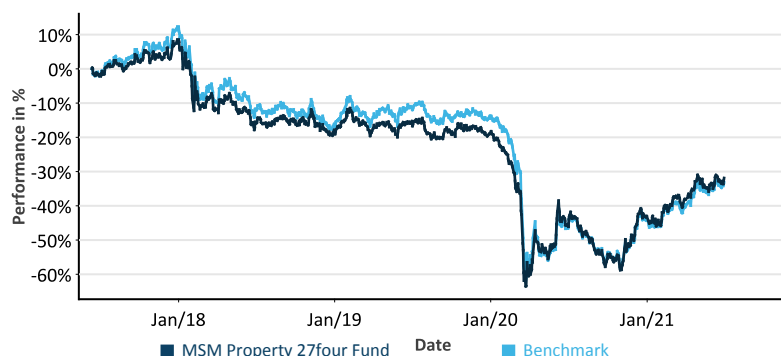
Investment Objective:

Monthly Commentary

The American economy continued its recovery with unemployment being reported at 5.8% as manufacturing activity rose. Concerns about inflation and the reflation trade saw markets fall back whilst the Fed saw inflation being transitory. Brent oil breached \$70 spurring global inflation on as global economies reopened. The Delta variant spread in the third wave witnessed in South Africa as lockdown restrictions increased from level 2 to level 4. Unemployment was reported at 32.6%, the highest in decades. SA GDP grew at 1.1%, equaling 4.6% vs 3.2% expected. We (+2.33%) underperformed the benchmark (+3.01%) as we took profits early in the month.

During the phase in period TERs do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER. The TER can be based on the management fee (including VAT) of 0.40% and projected audit fees, trustee fees, custody fees and other administration costs for the next 12 months. TCs can be based on costs incurred to date, annualised for the year, including STT and brokerage fees, VAT inclusive.

Risk Guidance

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.
