### MSM PROPERTY 27four FUND B2

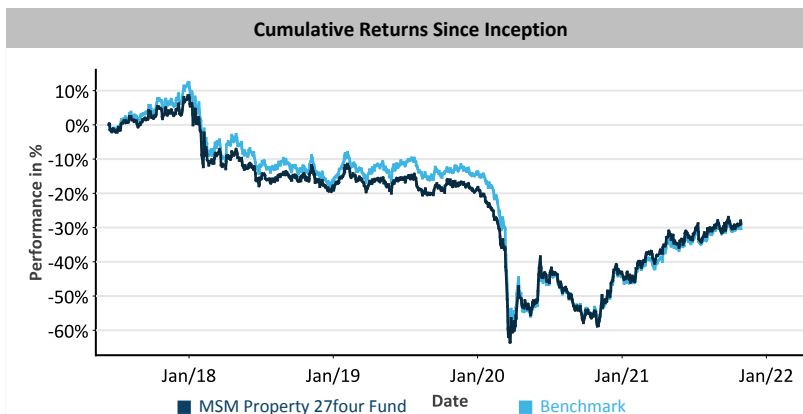
Investment summary: The fund invests in listed property equities listed on the JSE. Returns are likely to be volatile, especially over short- and medium-term periods. Suitable for those investors who seek exposure to JSE-listed property equities to provide long-term capital growth as well as a steady income stream. Typically have medium to long term investment horizon i.e. 1 year and more.

#### Investment Objective:

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, REITS, and cash.

#### Monthly Commentary

The month of October saw the beginning of US earnings, followed by EU earnings and FTSE/JSE earnings which lifted markets, with MSCI World index closing +5.66%. As a consequence, the Rand weakened on the back of the stronger Dollar and speculation about the Fed looking to taper and possibly increase interest rates. Commodity stocks performed well, yet financials and listed property gave back performance. The loadshedding and elections in South Africa didn't help as well. The FTSE/JSE SA Listed property was down -1.96% whilst we outperformed the benchmark with a -0.96% due to our defensive stance and offshore component in Sirius Real estate (+6.85%) and Iron Gate (+10.65%).

### Risk Guidance

**Highest & Lowest return:** The highest and lowest returns for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.
