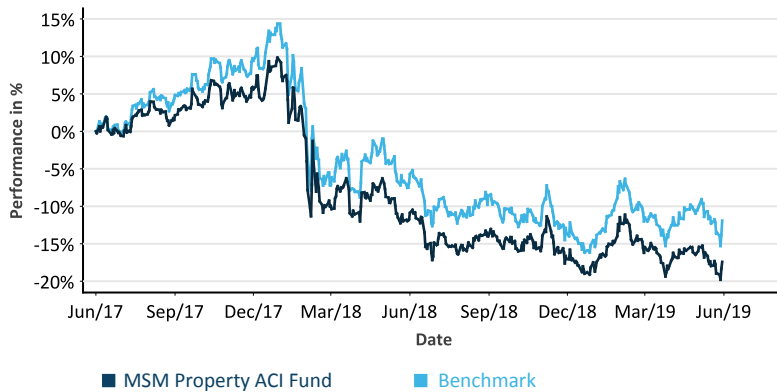


# MSM PROPERTY ACI FUND

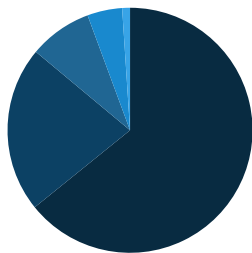

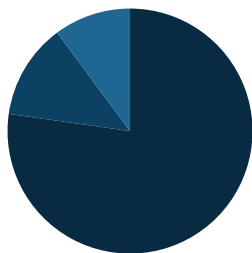

## Monthly Commentary

The jobs growth and GDP figures coming out of the U.S economy along with the trade talks between China and U.S, helped the first quarter of the year with worldwide stock advances, the best in 9 years. Also, central banks across the world took a dovish stance. In South Africa, Moody's rating agency delayed the investment decision on South Africa (after elections) along with the Chinese purchasing managers index which lifted all JSE shares. This contributed to the 2.38% for the month of April. Locally listed property shares outperformed the offshore component in the portfolio.

## Glossary summary

**Volatility:** Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest return:** The highest and lowest returns for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

## Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.

## Risk Guidance
