MSM PROPERTY ACI FUND B2

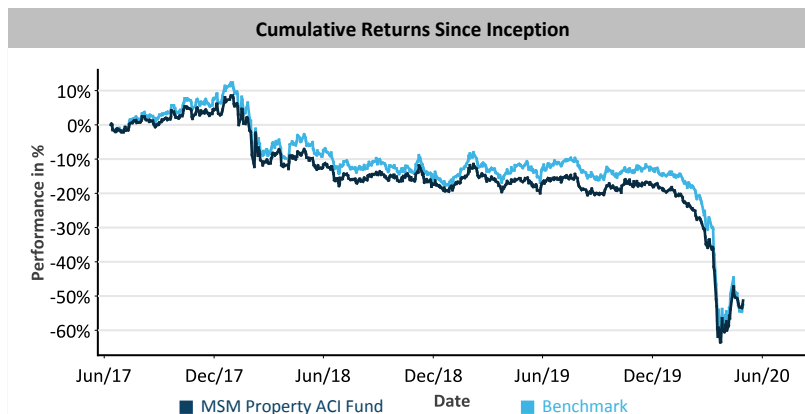
Investment summary: The fund invests in listed property equities listed on the JSE. Returns are likely to be volatile, especially over short- and medium-term periods. Suitable for those investors who seek exposure to JSE-listed property equities to provide long-term capital growth as well as a steady income stream. Typically have medium to long term investment horizon i.e. 1 year and more.

Investment Objective:

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, REITS, and cash.

Monthly Commentary

We outperformed both benchmarks as the fund gained by 17% vs 7% by the SA Listed Property Index and 5.68% by the All Property Index. Our risk-on stance benefitted from markets surging up as a response to countries beginning to open their respective economies. Russia and Saudi Arabia agreed to oil production cuts during a turbulent month for the commodity and investors rushed for Gold ETF's as the U.S jobs report exceeded 26million people who've lost their jobs. South Africa was downgraded, whilst SARB cut interest rates and bought R1bn worth of bonds. The president of South Africa released a R500bn package funded by international banks.

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER. The TER can be based on the management fee (including VAT) of 0.40% and projected audit fees, trustee fees, custody fees and other administration costs for the next 12 months. TCs can be based on costs incurred to date, annualised for the year, including STT and brokerage fees, VAT inclusive.

Risk Guidance

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.
