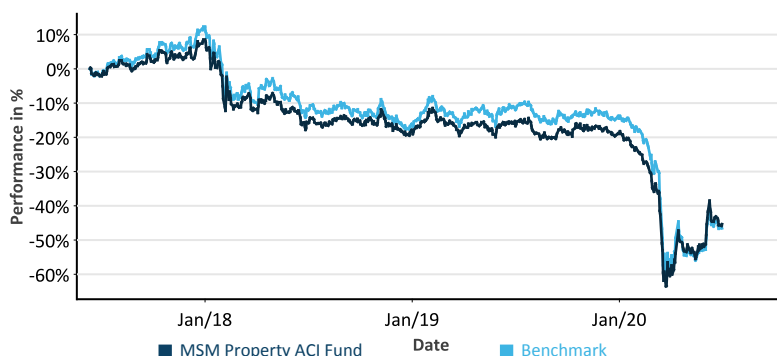
#### Investment Objective:

#### Monthly Commentary

Listed property jumped during June as value managers bought decimated equities caused by the Covid-crash. This was supported by the stimulus optimism. Markets ignored the Black Lives Matter movement along with second wave fears of the pandemic. The All Property index was up 12.94% whilst we beat the benchmark with a 13.63% return for the month. U.S and China relations worsened as China imposed its security law on Hong Kong whilst the Eurozone announced a EUR600bn package. South Africa recorded a -2% GDP print for the first quarter beating expectations of -4% whilst companies rushed to raise cash due to the uncertain economy.

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. ### Risk Guidance
