### MSM PROPERTY ACI FUND B2

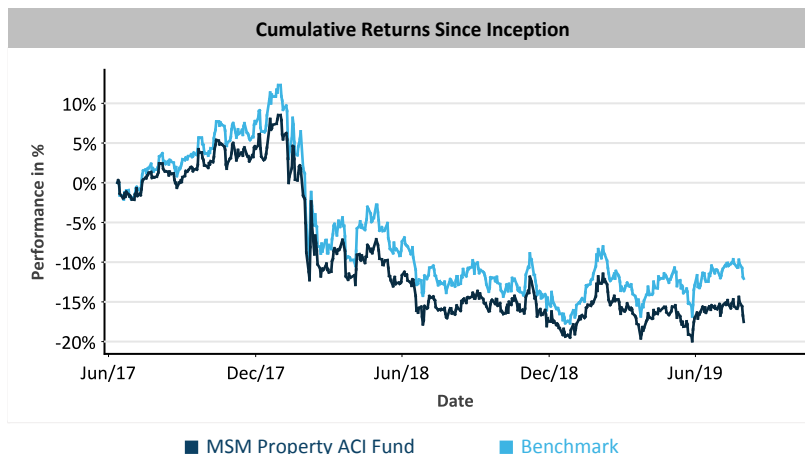
Investment summary: The fund invests in listed property equities listed on the JSE. Returns are likely to be volatile, especially over short- and medium-term periods. Suitable for those investors who seek exposure to JSE-listed property equities to provide long-term capital growth as well as a steady income stream. Typically have medium to long term investment horizon i.e. 1 year and more.

#### Investment Objective:

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, REITS, and cash.

**Monthly Commentary**

As the American economy beats growth estimates, the Dollar remains strong. Markets sell off after President Trump raises tariffs, seemingly in response to the Fed cutting rates only by 25bps (as IMF cuts global growth for 2019). Investors rush for Gold and bonds as markets sell off resulting in the SAPY being -1.20% and ALPI -2.60%. Boris Johnson becomes Prime Minister of U.K and adds to the rhetoric of a no-deal Brexit, which weighs heavily on UK property stocks along with poor earnings. The Reserve Bank cuts rates by 25bps. Moody's rates Eskom with a negative outlook, coupled with global events and the Rand weakens to R14.30.

### Risk Guidance

**Highest & Lowest return:** The highest and lowest returns for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.
